

<u>Attendee Guidelines for COVID-19</u> <u>Mitigation</u> (Updated April 7, 2021)

COVID plans are subject to change based on local, state, and federal guidelines.

Facility Certification

WI State Fair Park is a GBAC-certified facility, meaning that they have met the guidelines for cleaning and disinfecting for

COVID-19 (Coronavirus, SARS-CoV-2).

Things to Know Before You Go

If you or anyone in your group does not feel well or has any of the following symptoms, please do not come to the Car & truck show:

Fever, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, and diarrhea.

1) We highly recommend purchasing your ticket online prior to visiting the Car & truck show. You can save your electronic ticket(s) to your smartphone and scan them at the show entrance using our no-contact scanners.

2) Masks are mandatory and are to be always worn except when eating or drinking in a designated area. No medical exemptions.

3) Temperature checks are required and will be conducted at the entrance to the show. The temperature checks are non-contact. If you have a temperature above 100.4 you will not be admitted to the show.

4) By entering the show you are self-declaring that you do not have symptoms of Covid-19, you have not been exposed to anyone with Covid-19 and that you are not waiting for the results of a test for Covid-19.

Temperature Checks & Security

Show management will be conducting temperature checks on attendees at the show entrance and attendees will also need to complete a verbal self-declaration.

If you or anyone in your group does not feel well or has any of the following symptoms, please do not come to the car & truck show:

Fever, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, and diarrhea.

Personal Protective Equipment (PPE)

In accordance with local, state, and CDC guidelines and mandates, masks are required for all exhibitors, vendors, EACs, staff, and attendees to the Greater Milwaukee Int. Car & Truck Show. Masks must cover both the mouth and nose. If you are not able to follow this guideline please do not come to the show.

The car & truck show will have roving "Mask Ambassadors" who will remind attendees and exhibitors to wear their mask. Anyone who refuses to comply with the PPE mandate will be escorted out of the show.

Guest Hygiene and Transmission Prevention

For the health and safety of guests, hand sanitizer and hand washing stations will be located throughout the fairgrounds.

Signage will be placed throughout the fairgrounds to remind exhibitors, vendors, attendees, and staff of proper hygiene, to wear facemasks covering nose and mouth and physical distancing.

Test Drives

Test drives require that physical distancing be practiced among exhibitors, vendors and show attendees. Masks are required to participate in any test drives.

Vehicles and displays.

Vehicles displays and high touch areas will be cleaned and disinfected regularly throughout show hours. Deep cleaning will take place before show open each day
